TOTAL OPERATIONAL REVENUES WERE \$7,335,103 AND TOTAL EXPENSES WERE \$5,885,892. CEDAR LAKE RESIDENCES RECEIVED OPERATIONAL AND CAPITAL GRANTS FROM THE CEDAR LAKE FOUNDATION DURING 2015 TOTALING \$669,499.
